

How to apply September 2027



STOCKSBRIDGE
HIGH SCHOOL
— This is Just the Start —

All parents and carers who wish to secure a place for their child at Stocksbridge High School in September 2027 must:

- Apply online, or
- Complete a Common Application Form (CAF).

If you do not submit an application, your child is unlikely to be allocated a place—even if you live within the school's catchment area. Places are not automatically reserved for catchment area residents.

You are responsible for providing any supporting information relevant to your application. This may include:

- Medical documentation from a qualified professional
- Details of family circumstances
- Any other factors you believe are important

There are no strict rules about what to include—if you think it matters, include it.

Applications for secondary school places should be submitted to the Secondary Admissions team. School place allocations are managed by Community Schools in partnership with the City Council.

Timelines

July

Children attending Sheffield Primary Schools, will receive a leaflet and covering letter from your child's current primary school. The online application portal is now open.

September

September 24th September – Open Evening at Stocksbridge High School.

October

October 16th October – Final date to amend or submit online applications.

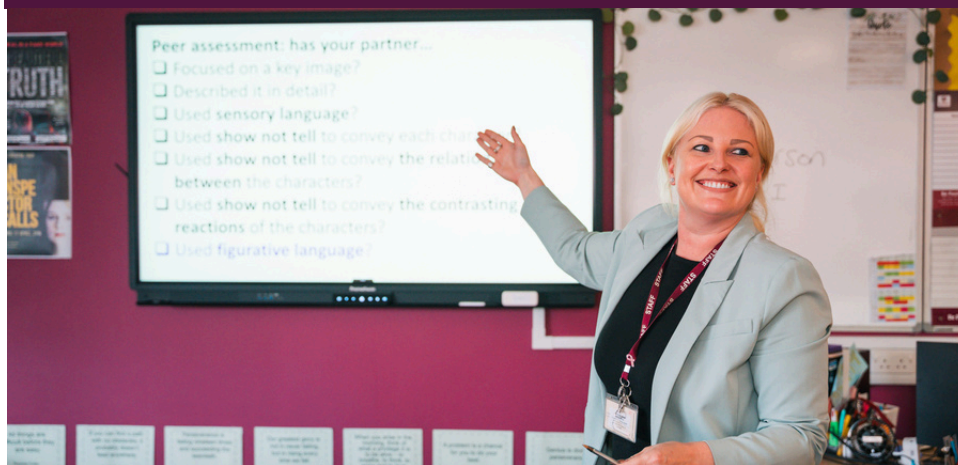
31st October – Final date to return your completed paper application form.

March

If you applied online, you'll receive an email with your child's school allocation. If you submitted a paper application, you'll receive a letter at your home address.

June

Appeals will be responded to.

Applying online

- Go to the Council's website: www.sheffield.gov.uk/schools-childcare/apply-school-place
- Click "Online Admissions" and register for an account. Enter your child's UID and date of birth (from the letter you received). If you don't have a UID, select "No UID" and
- enter your child's details manually.
- Choose up to three preferred schools.
- You'll be offered a place at the highest-ranked school with available space.
- Submit your application and confirm the information is correct.
- Print a copy of your application if you wish.
- Check your email for confirmation that your application has been received.

Over-Subscription Categories

Note: Children at non-catchment feeder schools have less chance of getting a place than those living in the catchment area or with siblings at the school.

1. Children in Care / Previously in Care

Includes children in care or previously in care, including those who were in state care outside England.

Note: Children at non-catchment feeder

schools have less chance of getting a place than those living in the catchment area or with siblings at the school.

2. Catchment Area + Sibling

Children living in the catchment area who will have a sibling at the school in September 2025.

6. Other Applications

Children who don't fall into any of the above categories will be considered next.

3. Catchment Area Only

Children living in the catchment area without a sibling at the school. Note: Living in the catchment area does not guarantee a place.

Places will be offered up to the school's published admission number.

4. Sibling Only

Children who will have a sibling at the school but live outside the catchment area. Parents and carers must note that, places cannot be guaranteed in future years for younger children.

5. Feeder School

If your child attends a designated feeder primary school but lives outside the catchment area, they may be offered a place after all higher-priority categories have been considered.

EHCP

Any child with an Education, Health and Care Plan (EHCP) that names a specific school must be offered a place at that school. This is a legal requirement under the Children and Families Act 2014. This applies regardless of oversubscription or catchment area status.
